This is in reference to application received from M/s Aceget Private Limited, regarding Consent for conducting Type Approval test of identified 05 models of Retrofit Emission Control Device (RECD) for Emission Compliance. The industry having registered office at 286, Bank Enclave, Laxmi Nagar, East Delhi-110092, has submitted the Notarized Affidavit as per Appendix - I (Part-A) of the System & Procedure. As per submitted documents, M/s Aceget Private Limited is engaged in Retrofitting of Retrofit Emission Control Devices (RECDs) in the brand names "(i) Aceget & (ii) APL".

Profile & details of the assembling facilities located at Plot no: C-35, Block-C, Sector-65, Noida, Gautam Buddha Nagar, Uttar Pradesh- 201301, have also been submitted as per Appendix – I (Part-B) of the System & Procedure. The applicant has selected the International Centre for Automotive Technology (ICAT), Manesar as Certification Agency to test the RECDs. Copy of the aforesaid documents is enclosed.

In this context, it is recommended that ICAT may proceed with the tests for Type Approval for emission compliance to M/s Aceget Private Limited as per the procedure after ascertaining adequacy of the documents & the infrastructure referring to "System and Procedure for Emission Compliance Testing of Retro-fit Emission Control Devices (RECD) for Diesel Power Generating Set Engines Up to Gross Mechanical Power 800 kW".

This consent is issued to conduct type approval test (emission compliance) of specific five models of RECD namely (i) APL/QUANTUM/005 (ii) APL/PRIME/005 (iii) APL/VORTEX/005 (iv) APL/NIMBUS/005 and (v) APL/ELEVATE/005 at ICAT, as mentioned in Appendix-I Part-B, for specific assembling facility of the retrofitter and not for contract retrofitting of any other type
